2020 APPLICATION FORM**

As part of a grant from the Centers for Medicare and Medicaid Services (CMS) and the Georgia State Survey Agency, these scholarships are intended to increase opportunities for GA nursing home staff and related stakeholders to gain training in various aspects of person-centered care.

This scholarship will provide GA nursing home staff and related stakeholders, including: residents, informal care partners for a resident (family, friend, volunteer), GA Long Term Care Ombudsman, and State of GA Surveyors, an opportunity to increase their skills in providing person-centered care.

You may register as an individual from a GA Nursing home, however, we recommend teams of 4-8 staff from the same nursing center apply. We suggest teams include at least one person from senior management, one-two department supervisors and the remainder direct care and other support staff. If possible, include other stakeholders such as a resident, family member, volunteer, or even your local ombudsman to participate with your team.

- 1. DEADLINE** for submission of scholarship applications is **Monday, August 17, 2020 for the 11-week online certification/class.**
2. Type or print legibly. Illegible or incomplete applications will not be accepted.
3. Applications may be submitted via email or fax.

SCHOLARSHIP AWARDS

- Applications will be reviewed as they are received and final decisions will be announced in advance of the training start date. You will be notified by email the status of your application.
- Applications will be considered on a first come-first served basis, and space is limited.
- The \$500.00 scholarship will cover the \$500.00 full registration fee. **If you receive a scholarship, you do not need to pay when registering to attend the training (use the scholarship code provided in the award letter).**

SCHOLARSHIP REQUIREMENTS

- Recipients are required to register directly with The Eden Alternative using the scholarship code you will be provided in the award letter.
- Recipients must log in on time for each session and participate for the entire 11-week training each Tuesday from September 8, 2020 through November 17, 2020.
- Recipients will be required to document what you learned at the Eden Associate Certification Training by completing a post-conference evaluation.
- Recipients will be required to document (on the post-conference evaluation) how you will share information and resources with peers and others.
- Recipients will be required to email/fax back a worksheet that documents how information was shared in their work or life 30-60 days after the event.
